This article does not affect the legal provisions of public order or mandatory law. The Auxiliary Persons may, as third-party beneficiaries, invoke the clauses of this article.

**For the purposes of this article, “Auxiliary Persons” shall be understood to mean any natural or legal person entrusted by Salto with the total or partial performance of a contractual obligation entered into by Salto, such as employees, directors and similar roles.*
