Salto Space Cookies Policy

Our website ProAccess Space (the “Website”), owned by Salto Systems, S.L., uses a technology known as “cookies” in order to gather information on the use of the Website. We use the cookies to analyse your using habits in order to improve the quality of our services and your user experience.

1. WHAT IS A COOKIE?

A cookie is a file that is downloaded on your computer or mobile device when accessing certain websites and apps, in order to store and retrieve information about the browsing made from such device.

2. WHAT TYPE OF COOKIES DOES THE WEBSITE USE?

2.1. Strictly necessary cookies:

- › Cookies ownership: We use strictly necessary cookies, the ownership and responsibility of which belongs to Salto Systems, S.L.
- › Purpose: These cookies are necessary for the correct performance of the essential functions of the website. They are used among other things to be able to log in, save your encoder preferences and save the date and time format. These cookies are necessary for the website to function.
- › Activation term: These cookies are permanent cookies.

2.2. Personalisation or functional cookies:

- › Cookies ownership: We use personalisation or functional cookies, the ownership and responsibility of which belongs to Salto Systems, S.L.
- › Purpose: These cookies are those that allow information to be remembered so that the user can access the service with certain characteristics that may differentiate their experience from that of other users, such as, for example, remembering the user and his password through an autofill tool, the appearance or content of the service depending on the type of browser through which the user accesses the service or the region from which the user accesses the service, etc. If it is the user himself who chooses these characteristics (for example, if he selects the date and time format), the cookies will be considered as a service expressly requested by the user and will therefore be used exclusively for the selected purpose and without requesting the user’s express consent.
- › Activation term: These cookies are active during 24 months as of their installation.

3. HOW DO YOU GIVE YOUR CONSENT?

You give your consent to the installation and use of the cookies subject to the terms of this Cookies Policy by clicking on the box "ACCEPT". Consent is valid for this website.

4. HOW CAN YOU MANAGE YOUR PREFERENCES?

You can set your preferences and configure the use of cookies in the settings panel available in the banner or in the section "About" accessing to the configure cookies option. Therefore, if you would like to remove at any time your consent to the use of functional cookies you must disable their use by changing the settings. Strictly necessary cookies cannot be removed since they are necessary for the correct performance of the essential functions of the website.

Also, please note that at any time you can block or disable, as well as delete previously installed cookies by modifying your browser options, for which you must follow the corresponding instructions.
